# What sort of information does Crispin & Jeffery collect and hold?

- Crispin & Jeffery collects information when you engage the organisation so that Crispin & Jeffery may
  provide you with financial planning / tax / superannuation / accounting / mortgage broking / business
  advisory / audit services.
- Crispin & Jeffery collects personal information from you to comply with our legal obligations to provide you
  with informed and appropriate financial advice.
- Crispin & Jeffery will only collect information relevant to our business relationship with you. The information
   Crispin & Jeffery collect will include contact details, personal details such as your occupation and place of
   birth, financial information and other information that we require to provide you with our services.
- Crispin & Jeffery collects information from the Australian Taxation Office while dealing with your personal information and/or information relating to your finances.
- Crispin & Jeffery collects personal information from your employer regarding employment, contributions and/or length of service.

#### **How Crispin & Jeffery collects this information**

- How Crispin & Jeffery collect this information will depend upon how you interact with us. Crispin & Jeffery
  may collect your personal information directly from you in face to face meetings, over the phone, via
  email, via other electronic means or via the C&J SMSF Dashboard for your Crispin & Jeffery administered
  SMSF.
- If you have authorised Crispin & Jeffery to collect personal information directly from other sources, such as your service providers (superannuation, insurance, investments, etc.) or from your other advisers (financial planner, lawyer, banker, etc.), Crispin & Jeffery may collect this information in person, via the telephone, mail, fax, email or internet contact.
- When you visit the Crispin & Jeffery website, we collect various information to assist us in improving the usage of the website and to provide you with information relevant to your needs.
- Crispin & Jeffery collects personal information from your employer regarding employment, contributions and/or length of service.

- Crispin & Jeffery also uses your personal information to send information to you that you request. This will
  be sent via post or email, or posted to the C&J SMSF Dashboard, for your Crispin & Jeffery administered
  SMSF.
- Crispin & Jeffery will not collect any sensitive information, such as information relating to your health, unless this is necessary to provide you with a specific product, service or tax offset, such as life insurance policies, and you have consented to that collection.
- When you speak to Crispin & Jeffery about your personal financial affairs, Crispin & Jeffery will minimise the opportunity for external parties to overhear our discussion.

#### Why does Crispin & Jeffery collect this information?

- Our business is to understand and meet our clients' needs over their lifetimes for a wide range of financial and other services. To do this effectively, Crispin & Jeffery must collect certain information.
- Crispin & Jeffery collects the Information to provide you with a specific service. For example, we may
  use the Information you provide us to track your superannuation entitlements, determine your income
  tax status, prepare your annual income tax return, pay you a lump sum or pension etc.

#### Will your information be disclosed to overseas recipients?

 Part of our trained team who may assist in completing this assignment are located in the Philippines. Your financial records for this work will at all times remain on secure servers located in Australia.

## What will we limit the use of your personal information to:

- Recommending to you, or providing you with the financial products and services and taxation advice that you may need.
- Carrying out planning, product development, research and analyses.
- Fulfilling ourlegal requirements.

We may use your information to offer you products and services that we believe meet your needs. However, you can notify us at any time if you do not wish to receive these offers by calling us on (02) 9908 4744, by writing to us at Level 16, 68 Pitt Street SYDNEY, NSW 2000 or by unsubscribing to marketing emails. Crispin & Jeffery will act promptly on any such request.

# Who will use your information?

- Unless you are informed otherwise, the personal information Crispin & Jeffery holds is used for establishing and
  managing your financial affairs and related services, reviewing your ongoing needs as well as enhancing
  customer service and product offerings.
- Crispin & Jeffery will not share, sell or trade your personal information to any company or person who is not a member of Crispin & Jeffery.

# Crispin & Jeffery may provide information to the following:

- The Australian TaxationOffice
- Your financial adviser and the dealer group they are licensed under
- The Trustee(s) of your superannuation fund
- Your legal representative
- Any government agency or department that is entitled by legislation to access this information
- Lending institutions and other parties that may specifically request information from time to time and for which we have your written approval to provide the information

# Will your information be secure?

Safeguarding your information is important to us, whether you interact with us personally, by phone, mail, over the internet or other electronic medium. We hold personal information in a combination of secure computer storage





facilities, paper-based files and other records, and take steps to protect the personal information we hold from misuse, loss, unauthorised access, modification or disclosure.



Crispin & Jeffery has security measures designed to protect against the loss, misuse and/or alteration of the Information under its control.

These security measures include:

- Password controlled and restricted access to your personal information
- Firewalls installed on the computer servers
- Employee agreements requiring confidentiality
- Only minimal information retained in hard copy format most is storedelectronically
- Security controlled building
- Password controlled access to main storage servers available only to administrators of the system not general staff

We may need to maintain records for a significant period of time. As a guide, the law generally requires us to retain information for seven years. However, we may retain some information for shorter or longer periods than this, depending upon any specific legal requirements and the needs of the business. When we consider information is no longer needed, we will remove any details that will identify you or we will securely destroy the records.

## Will you have access to your information?

# You can access most of the personal information we hold about you and request corrections

This service is free unless the information you request requires significant research or preparation time. Before we act upon requests of this nature, we will tell you how much this service will cost.
- The right to access your personal information is subject to some exceptions. For example, you may not obtain access to information relating to existing or anticipated legal proceedings.
